I am calling because I believe the killings in the Philippines must stop.

I join the **International Coalition for Human Rights in the Philippines** in seeking justice for the over 13,000 Filipinos killed in the war on drugs and the numerous other victims of extrajudicial killings under President Rodrigo Duterte.

I am concerned that even more people will be killed because President Duterte has called for the extension of Martial Law in the Philippines for another year.

I am appalled that my tax dollars have contributed to the Philippine National Police and Armed Forces of the Philippines which have committed these human rights violations.

I support the call of Bill S-1055 to end U.S. funding of the drug war.

I also call for amendments to the bill that address two further problems:

- Extrajudicial killings at the hands of the Armed Forces of the Philippines; and
- U.S. complicity in those killings through training and funding of the Armed Forces of the Philippines under the Mutual Defense Treaty and the Enhanced Defense Cooperation Agreement.

As a constituent of your district, I ask you to support these calls so we can stop the killings in the Philippines and stand up for human rights. I do not want any of my tax dollars to go to President Duterte's murderous wars on the Filipino people.
